# Association Notes.

- 1. Capt. R. R. Chibba, Hony. Secretary of the Association having been transferred to Madras, Mr. G. S. Mitter, Hony. Asst. Secretary agreed to carry on the work of the Hony. Secretary until the next election and Mr. M. N. Mitra agreed to work as Hony. Asst. Secretary.
- 2. Quotations for printing the Association Journal received from various printing Presses were considered and it was decided that Messrs. Glasgow Printing Co. who did this work previously for the Association, be given a further trial.
- 3. As the new collecting sircar, Shri Anil Kumar Guha was found unsuitable for the job, his services were dispensed with.
- 4. The office peon Gour Chandra Das was granted an increment of Rs. 5|- p.m. with effect from 1st June, 1948.

- 5. The question of appointment of a member in the chain of vacancies caused in the Council by Capt. Chibba's transfer to Madras was placed before the Council for consideration. As Capt. Chibba had not resigned his secretaryship, the Council decided that the question of vacancy did not arise.
- 6. The financial position of the Association for the half-year ending 30th June 1948 was considered by the Council. The Council recorded its opinion that the financial position indicated the need for exploring other sources of income, or for increasing the income by raising the rates of subscriptions.
- 7. The following recommendations of the "Arrears Subscriptions Sub-Committee" were approved and accepted by the Council:

- (b) Regarding deposits against issue of books, the Subcommittee decided that rare books and books of reference as may be classified by the sub-committee, must on no account be issued. Other books may be issued but not more than one volume at a time against a deposit of Rs. 20|-.
- (c) With regard to the scope of function of the Sub-committee it was decided that the Sub-committee should also deal with matters connected with the publication of the Journal, e.g. purchase of paper, securing advertisements through the Advertising Agency, or otherwise. It was also decided that henceforward the Library Sub-committee should be re-named "the Library and Journal Sub-committee."
- 9. In reply to his letter dated 28th June, 1948, Capt. Chibba was informed that the Council had no objection to his continuing as the Hony. Secretary of the Association till the next election, since arrangement for carrying on his work during his absence from Calcutta had already been made.
- 10. The Council considered a letter from the All-India Board of Technical Studies inviting suggestions regarding improvement of the technical studies in India. 11. The Council expressed its deep sense of sorrow on the untimely death of one of the Associate Members of the Association, Shri Gunendra Nath Banerji, and conveyed its sincere condolence and sympathy to the bereaved family.

12. A letter dated Bezwada, the 25th June, 1948, from Shri R. V. Natarajan, A.M.A.E., suggesting increase in the existing rates of subscriptions in the case of the Corporate members of the Association was considered by the Council.

It was the considered opinion of the Council that the existing rates of subscriptions were extremely low, out-of-date and quite unsuited to the present-day economic condition of the country and that, with the income derived from these subscriptions, it would be impossible to run the day-to-day affairs, or even maintain the status quo and the normal activities of the Association. In the opinion of the Council it was imperatively necessary to increase the rates of subscriptions. The Council decided therefore that the following revised scales of subscriptions and admission fees should be adopted with effect from January 1949, subject to ratification of the same at a general meeting of the Association:—

The Council considered whether the Association should assume the role of an advisory body in the matter of appointment by the Corporation of Calcutta of Engineers and Architects as their Licensed Building Surveyors, and if so, on what lines should the Association address the Corporation in the matter and what precisely the Association's recommendations should be.
